

## WEBSITE PRIVACY POLICY

Welcome to our Website (the "Site").

We understand that online privacy is important to users of our site, especially in conducting business.

This statement governs our privacy policies with respect to users of the Site ("Visitors") who visit, without business transactions and visitors who register to conduct business transactions on the site and make use of the various services offered by REPTILES OF THE COSTA ATLANTICA SAS (collectively, "Services") ("authorized customers").

**"Personally Identifiable Information"** means any information that identifies or may be used to identify, contact or locate the person to whom such information belongs, including, but not limited to, name, address and telephone number, fax number, E-mail address, financial profiles, social security number and credit card information. Personally Identifiable Information does not include information that is collected anonymously (ie without individual user identification) or demographic information is not connected to an identified individual.

**What personal identification information is collected?** We can collect basic user profile information from all our visitors. We collect the following additional information from our authorized customers: the names, addresses, telephone numbers and emails of authorized customers, the nature and size of the business, and the nature and size of the advertising inventory that the authorized customer is proposed to acquire or to sell.

**What organizations are collecting information?** In addition to our direct collection of information, our third-party service providers (such as credit card companies, clearinghouses and banks) who can provide services such as credit, insurance and custody services can collect this information Of our visitors and authorized customers. We do not control how these third parties use such information, but what if we ask them to disclose how they use the personal information provided to them from authorized visitors and customers. Some of these third parties may be intermediaries who act only as links in the distribution chain, and do not store, retain or use the information given to them.

**How does the site use Personally Identifiable Information?** We use personally identifiable information to personalize the site, to make appropriate offers of the service, and to comply with purchase and sale requests on the site. We may send e-mail to visitors and authorized customers about research or purchase and sale opportunities on the Site or information related to the subject of the site. We may also use personally identifiable information to contact authorized visitors and customers in response to specific questions, or to provide the requested information.

**With whom can the information be shared?** Personal identification information about authorized customers may be shared with other authorized customers who wish to evaluate Potential transactions with other authorized customers. We may share aggregate information about our visitors, including demographics of our visitors and authorized

customers, with our affiliated agencies and third-party providers. We also offer the opportunity to opt out of receiving information or be contacted by us or by any agency acting on our behalf.

**How do I store personally identifiable information?** Personal Identification Information collected by REPTILES DE LA COSTA ATLANTICA S.A.S is stored securely and is not accessible to third parties or employees of REPTILES DE LA COSTA ATLANTICA S.A.S, except for its use as indicated above.

**What options are available to visitors regarding the collection, use, and distribution of information?** Visitors and authorized customers may choose not to receive the requested information or to be contacted by us and / or our suppliers and affiliates in response to the emails as instructed.

**Are cookies used on the site?** Cookies are used for a variety of reasons. We use cookies to obtain information about the preferences of our visitors and the services you select. We also use cookies for security purposes to protect our authorized customers. For example, if an authorized client logs on to the site and is not used for more than 10 minutes, the authorized client session is automatically closed.

**How do REPTILES DE LA COSTA ATLANTICA S.A.S uses login information?** REPTILES DE LA COSTA ATLANTICA SAS uses login information including, but not limited to, IP addresses, ISPs, and browser type, to analyze trends, manage the site, track user movement and usage, and collect information Demographic

**Which partners or service providers have access to personally identifiable information from visitors and / or authorized customers on the site?** REPTILES OF THE ATLANTIC COAST S.A.S has entered and will continue to establish associations and other affiliations with a number of vendors. Sellers may have access to certain personally identifiable information about the need to know the basis for the evaluation of authorized customers for service eligibility. Our privacy policy does not cover your collection or use of this information.

Disclosure of Personally Identifiable Information to comply with the law. We will disclose personally identifiable information in order to comply with a court order or subpoena or a request by a law enforcement agency to disclose information. We will also disclose personally identifiable information when reasonably necessary to protect the safety of our visitors and authorized customers.

**How does the site keep your personally identifiable information secure?** All our employees are familiar with our security policy and practices. The personally identifiable information of our visitors and authorized customers is only accessible to a limited number of qualified employees who are given a password to access the information. We audit our security systems and processes on a regular basis. Confidential information, such as credit card numbers or social security numbers, is protected by encryption protocols, in place to protect information sent over the Internet. While we take commercially reasonable measures to maintain a site

Secure, electronic communications and databases are subject to errors, manipulations and theft, and we can not guarantee or ensure that such events will not be carried out and will not be liable to visitors or authorized customers of any occurrences.

**How can visitors correct any inaccuracies in personally identifiable information?**

Visitors and authorized customers may contact us to update personally identifiable information about them or to correct any inaccuracies in responding to emails as instructed.

**Can a visitor delete or deactivate personally identifiable information collected by the site?**

We offer visitors and authorized customers the mechanisms to remove personally identifiable information from the Site database, responding to emails according to instructions. However, because of backups and deletion logs, it may be impossible to delete a visitor's entry without retaining some residual information. An individual requesting that the personally identifiable information be deactivated shall have this information functionally deleted, and we will not sell, transfer or use the personally identifiable information relating to that person in any way to proceed.

**What happens if there are changes in the privacy policy?** We will let our visitors and authorized customers know about changes to our privacy policy by posting such changes on the site. However, if we are changing our privacy policy in a way that could cause the disclosure of personally identifiable information that a visitor or authorized customer has previously requested, it will not be disclosed, we will contact for visitor or customer authorization to allow it or To avoid such disclosure.
